Dear Sir/Madam,

In pursuant to Regulation 15 of SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015, the compliance with the corporate governance provisions as specified in Regulation 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) and (t) of sub-regulation (2) of Regulation 46 and Para C, D and E of Schedule V shall not apply, in respect of a listed entity:

**a.** Having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty-five crore, as on the last day of previous financial year.

Our Company falls below the required threshold limit as mentioned under Regulation 15(2)(a) of the SEBI (LODR) Regulation, 2015 as the paid-up equity share capital does not exceed rupees ten crore and the net worth does not exceed rupees twenty-five crore, as on the last day of previous financial year. Hence the above-mentioned LODR Regulations in Para 01 are not applicable to us.

However, as a matter of good compliance and for the best interest of the shareholders/stakeholders, the Company is voluntary complying with Regulation 27(2) of the SEBI (LODR) Regulations, 2015 i.e. the quarterly submission of the Corporate Governance Report for the quarter ended December 31, 2023

Further, the Company also declares and undertakes that when the Regulations as mentioned in Para 01 becomes applicable to our Company at a later date, the Company will duly comply with the requirements of the above Regulations within six months from the date on which the provision becomes applicable to us.
