ORDER

1. The Applicant Company has presented this application under Section 13(4) of the Companies Act, 2013 (hereinafter referred to as 'the Act') vide SRN No. AA6382888 dated 14.12.2023 to the Regional Director (SER), Hyderabad for confirmation of alteration of the registered office clause of the Memorandum of Association of the company so as to change the place of registered office from **State of Karnataka to the State of Telangana** as approved by special resolution passed in accordance with Section 114(2) of the Act in its Annual General Meeting held on 23.09.2023.
2. The Applicant Company was incorporated on 29.01.1980. The company stated in its justification that the proposed change in the registered office from the **State of Karnataka to the State of Telangana** would enable the Company to control its operations in a better manner and for administrative convenience.
3. Taking into consideration the contents of the application and affidavits filed in support thereof and Report dt 02.01.2024 of the Registrar of Companies, Bangalore and keeping in mind the fact that the company has duly complied with the requirements of provisions of Rule 30 of the Companies (Incorporation) Rules 2014, and no objections received from any stakeholders till date, I have come to the conclusion that the application deserves to be allowed.

This Application is allowed.

The alteration in the Memorandum of Association of the Petitioner Company as approved by special resolution passed in accordance with Section 114(2) of the Act in its Annual General Meeting held on 23.09.2023 and in exercise of the powers vested with the undersigned vide Notification No. S. O. 4090(E) dated 19.12.2016 issued by the Government of India, Ministry of Corporate Affairs, is hereby confirmed as set forth in the schedule hereto and forming part of this order. However, this order is subject to the condition that interest of no employee working at the registered office of the company shall be adversely affected either by way of transfer or retrenchment or otherwise and order accordingly. There will be no jurisdictional change in the legal proceedings pending against the company on the date of this order.
